### MINUTES OF BOARD OF TRUSTEES: October 17, 2014 CLEAR LAKE SANITARY DISTRICT, CERRO GORDO COUNTY, IOWA

The meeting was called to order by President John Miller at 1:30 p.m. Miller indicated to those present that the meeting was being tape recorded for meeting minute generation purposes only.

Item # 1. Approve proposed agenda. Motion by Clark, second by Meyer to approve the proposed agenda. Motion carried, all Trustees present voting 'aye'.

Item # 2. Opportunity for public to speak on items not on the agenda. No public to speak on items not on the agenda.

Item # 3. Approve September 2014 Financial Statement. Motion by Wolfram, second by Clark to approve the September 2014 Financial Statement. Motion carried, all Trustees present voting 'aye'.

Item # 4. Approve September 2014 Invoices. Motion by Wolfram, second by Meyer to approve the September 2014 Invoices. Motion carried, all Trustees present voting 'aye'.

Item # 5. Approve September  $15^{th}$ , 2014 board meeting minutes. This was tabled until the next meeting.

Item # 6. Outstanding Receivables. Moler noted that we've been trying to collect on the outstanding Pit & Septic invoices for several years without success. The auditors mentioned the amount is very old and recommended that it be written off at this point. Motion by Clark, second by Meyer to write off the old debt and not allow them to dump until the bill has been paid up. Motion carried, all Trustees present voting 'aye'.

Item # 7. HVAC & Lighting Upgrade.

- Change Order No. 2.
- Pay Request No. 5.

These items were tabled.

Item # 8. Employee Benefits and Compensation.

- Medical Insurance Contract. Moler and the Board discussed several options on how to handle the increase in medical premiums. Motion by Clark, second by Wolfram to approve the contract with Wellmark Blue Cross Blue Shield, raising the premiums paid by employees by \$15 per month and seeding employee HSA accounts with \$3,000 and reimbursing up to \$4,000 for the next calendar year. Motion carried, all Trustees present voting 'aye'.
- Dental Insurance Contract. Moler stated the premium would go up about \$60 a month for the dental if the District stays with Principal Financial. Moler said the other plans were not worth looking at based upon what they offer. Motion by Clark, second by Meyer

to approve the Principal Financial Dental Insurance renewal. Motion carried, all Trustees present voting 'aye'.

• Compensation Adjustment. Motion by Meyer, second by Wolfram to approve a 2.5% raise for employees. Motion carried, all Trustees present voting 'aye'.

Item # 9. West Lake Street Sewer Service Connections. Moler explained that the District installed a sewer line in 2005 on West Lake Street in Ventura. At the time there was not a subdivision, so sewer lines for the properties were not stubbed in. And whoever connects to the sewer has to dig seventeen feet down to connect to the sewer and then will be billed \$3,500 for a connection fee. The cost to dig down seventeen feet in order to connect is estimated at around \$1,700. Moler said with some additional equipment and using the jet truck the District could stub in these connections. Motion by Wolfram, second by Meyer to purchase the equipment to allow the District to make these types of connections. Motion carried, Clark abstained from voting, Miller, Meyer, and Wolfram voting 'aye'.

Item #10. Equipment Quotes.

- Tower Components. The quote for the safety cable (stainless) came in at \$1,759. There were antenna cables also needed, these were quoted at \$2,958. Standoffs were also needed at the top of the tower; these were quoted at \$1,740.
- SBR Decanter Floats. Moler stated that the quote for one float came in at \$5,520, plus an additional \$950 in shipping. If we were to buy two floats it would be \$4,520 per float, for a total of \$9,990 including shipping.
- Surveillance System. The quote for eight cameras and a central recording device was \$11,428. An additional \$17,996 for the remote sites was quoted. The total quote for cameras and recording equipment for local and remote sites, including installation, is a total of \$29,424. The lift stations will require additional antennas, control panels, radios for communication and video, and programming for everything, all which will be done by the District's integrator. The quote for this came in at a rough number of \$80,000. If the District installs the shelving and control panels and wiring ourselves the quote would drop to around \$40,000 to \$50,000. This was tabled until final quotes have been received.
- Lift Station 7 Pump. Moler said that someone had flushed some underwear, it got into a pump at Lift Station 7, and ruined the pump. The pump needs to be replaced. The quote from Iowa Pump Works was \$5,882, including shipping.

Motion by Meyer, second by Clark to approve the quotes for the tower components, SBR decanter floats, and pump for Lift Station #7. Motion carried, all Trustees present voting 'aye'.

Item #11. Account Adjustment 011850-000. The owners recently noticed that they were being billed at a five bedroom rate. They called and informed us that this is a two bedroom house. The District's information is based upon the county's information from years ago. Moler sent McLaughlin and Moore to check out the house, and they confirmed that it is definitely a two bedroom house. Motion by Clark, second by Wolfram to change this billing from five bedrooms to two bedrooms going forward. Motion carried, all Trustees present voting 'aye'.

Item #12. Lift Station 5 Easement Request. This item was tabled.

Item #13. Unfinished Business. No unfinished business to be discussed.

Item #14. Superintendent's Report. The annual inspection from the DNR occurred on September 9<sup>th</sup>. There were three recommendations on the report. First was to make sure to report any backups or bypasses to the DNR within 12 hours. Second was to establish a

treatment agreement with Powdercraft in Clear Lake as they are a metal finisher and require a treatment agreement. Lastly was to register and get an air permit for the new generator at Lift Station 7.

Item #15. Attorney's Report. No report.

There being no further business to discuss, motion by Wolfram, second by Meyer to adjourn. Motion carried, all Trustees present voting 'aye'. Meeting adjourned at 3:51 p.m.
