The regular board meeting was called to order by President Bale at 5:30 p.m. Bale indicated to those present that the meeting was being tape recorded for meeting minute generation purposes.

Bale noted that the agenda needed to be amended to add Resolution 24-01. Motion by Adams, second by Wolfram to add Resolution 24-01 to the agenda as Item #4A. Motion carried, all Trustees present voting 'aye'.

Item #1. Election of CLSD Board Officers. Motion by Wolfram, second by Adams to maintain the same officers as 2023, Bale as President, Nelson as Treasurer, and Adams as Clerk. Motion carried, all Trustees present voting 'aye'.

Item #2. Opportunity for public to speak. No public present.

Item #3. Consent Agenda: Approve December 2023 Financial Statement.

Approve December 2023 Invoices.

Approve December 19th, 2023 Board Meeting Minutes.

Motion by Adams, second by Wolfram to approve the Consent Agenda. Motion carried, all Trustees present voting 'aye'.

Peterson entered at 5:36 p.m.

Item #4. Infrastructure Upgrade Project – Pay Request #10 \$678,936.54. Graupman gave an update on the project and the expected schedule including some potential equipment delays. Motion by Adams, second by Petersen to approve the Infrastructure Upgrade Project Pay Request #10 in the amount of \$678,936.54. Motion carried, all Trustees present voting 'aye'.

Item #4A. Resolution 24-01. A Resolution Certifying Delinquent Sewer Accounts as a lien upon the real property serviced by a connection. Motion by Peterson, second by Wolfram to approve Resolution 24-01, a resolution certifying delinquent sewer accounts as a lien upon the real property serviced by a connection. President Bale called the roll with the following results: Peterson, 'aye'; Wolfram, 'aye'; Adams, 'aye'; and Bale, 'aye'. Motion carried.

Item #5. Electricity Interrupt Contract. Hanson explained that Alliant made an addendum to the Interrupt Contract, as the credit amounts have changed, resulting in better savings for the District, albeit a longer contract period. Hanson noted that the District will still have a 90 day window to get out of the contract if something were to happen. Motion by Peterson, second by

Wolfram to approve the addendum to the Alliant Electricity Interrupt Contract. Motion carried, all Trustees present voting 'aye'.

Item #6. Tertiary SCADA Improvement Project – Pay Request #12 \$20,637.20. Motion by Adams, second by Peterson to approve the Tertiary SCADA Improvement Project – Pay Request #12 in the amount of \$20,637.20. Motion carried, all Trustees present voting 'aye'.

Item #7. Lab Remodel Project – Pay Request #3 \$47,634.98. Motion by Peterson, second by Wolfram to approve the Lab Remodel Project – Pay Request #3 in the amount of \$47,634.98. Motion carried, all Trustees present voting 'aye'.

Item #8. Unfinished Business. No unfinished business to be discussed.

Item #9. Administrator's Report. Hanson stated that Alliant is looking into a chemical room addition and some necessary improvements to the tertiary building, including a new UV system. Hanson said that a mixer went down in Digester #1 and needs to be replaced. One quote received was for \$4,000.00 plus shipping. In addition, the mixers and floats are in need of replacement. Hanson discussed doing two next year and two the year after that. Lastly, Hanson noted that the two fraudulent whitewashed checks have been taken care of and the District has been reimbursed.

Item #14. Trustee's Report. Bale reminded the Board of the Budget Workshop set for Monday, January 22nd, 2024 at 7:30 a.m.

There being no further business to discuss, motion by Adams, second by Peterson to adjourn. Motion carried, all trustees present voting 'aye'. Meeting adjourned at 6:26 p.m.
